This Amendment No. 1 to the Annual Information Form provides certain additional information in respect of the Fund. The Annual Information Form should be read subject to this information. In all other respects, the disclosure in the Annual Information Form is not revised. All capitalized terms not defined herein have the respective meanings set out in the Annual Information Form.

### **Change of Portfolio Advisor**

The Annual Information Form is amended to reflect the change of portfolio advisor of the Fund from Ariel Andres to Antonio Scilipoti effective October 1, 2020, subject to regulatory approval. No material changes have been made to the investment objective or strategies of the Fund.

Accordingly, the following changes are made to the Annual Information Form:

1. the second paragraph under the heading of “Portfolio Advisor” on page 9 of the Annual Information Form is hereby deleted and replaced by the following:

“The individual who is principally responsible for the day-to-day management of the portfolio of the Fund is Antonio Scilipoti.”

2. the third paragraph under the heading of “Portfolio Advisor” on page 9 of the Annual Information Form is hereby deleted and replaced by the following:

*“Antonio Scilipoti*

Mr. Scilipoti is a co-founder of the Veritas Group of Companies and serves as a Director and the President, CEO, Ultimate Designated Person and Chief Compliance Officer of the Manager. He was trained as a forensic accountant and is designated as a Fellow Chartered Professional Accountant, Certified Professional Accountant (Illinois) and is also a member of the Association of Certified Fraud Examiners. Anthony is reassuming his role as lead portfolio manager and has been part of the Manager’s portfolio management team since its inception in 2017.”
