PORTFOLIO OBJECTIVE

The investment objective of the Fund is to achieve attractive risk adjusted rates of return that deliver long-term capital appreciation to unitholders.

The Fund will invest primarily in the securities of publicly traded Canadian companies that the portfolio management team identifies as mispriced. Long and short positions will be determined with reference to recommendations provided by Veritas Investment Research Corporation (an affiliate of the Portfolio Manager). The Portfolio Manager may also invest in securities that are not formally covered by Veritas Investment Research Corporation.

The Fund will manage its long and short positions to reduce the impact of market volatility on the Fund's investment portfolio.

COMMENTARY

Series F of the Veritas Absolute Return Fund generated a -1.8% return in July versus a 4.7% return for S&P/TSX index, bringing our year-to-date return to -3.7% versus a -5.7% return this year for the index. Despite a July rally in risk-assets that negatively impacted our short book, our lower-risk positioning has served the Fund well this year. We remain focused on generating absolute returns for our investors while maintaining our low market correlation to minimize volatility.

The Fund's short position in **Roku Inc. (NASDAQ: ROKU)** was the top contributor to fund performance in July, as the company's second quarter results missed revenue and earnings estimates, leading management to withdraw its full-year guidance. Like many of its consumer-oriented technology peers, **ROKU's** business model is overly reliant on advertising revenues, which continue to weaken in Q3.

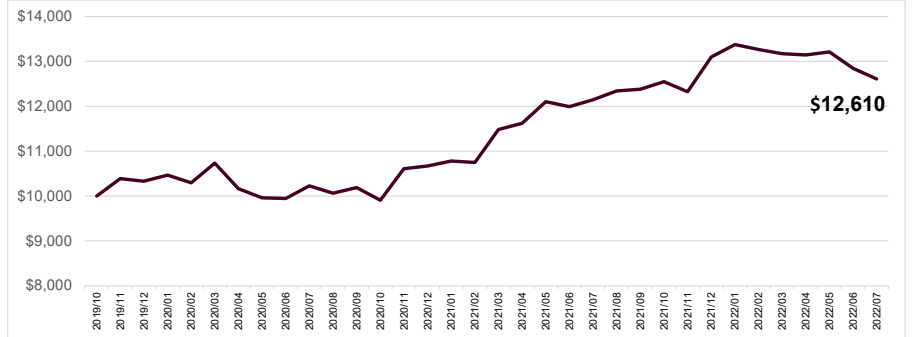
The Fund's long position in **Capital Power (TSX: CPX)** was the second largest contributor to fund performance in July. **CPX** announced a 50-50 joint venture with Manulife Investment Management to acquire a 1.6GW cogeneration facility in Michigan. Despite the facility's out-years carrying some contractual risks and merchant exposure, we like the deal and view it as accretive. In the near-term, the new facility triggers an increase in management's adjusted funds flow outlook of close to 20%.

Our goal is to buy the best companies in sectors where we identify positive investment catalysts and take strategic short positions in poorly positioned companies in challenged industries. We evaluate each company's ability to navigate good and bad economic environments, looking at the sustainability of cash flows; balance sheet strength; financial reporting transparency and governance.

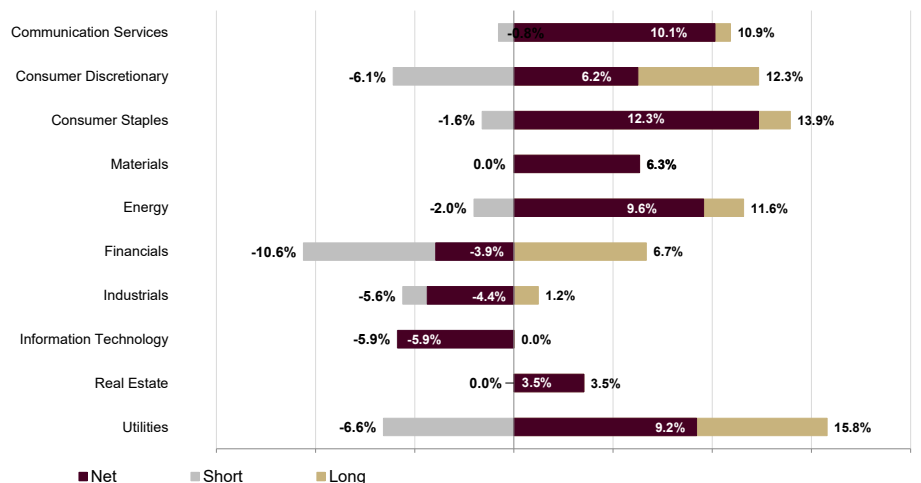
Growth of \$10,000 (since inception date)
